All licenses have a validity of 20 years.

Single License

A single license locks the software to a single computer. The single license can be unlocked and transferred to another computer by the user.

Floating License

A floating license allows the software to be installed and used on multiple computers until the maximum number of users has been reached.

Multiple Licenses / Users

The price list shows the prices for single licenses and floating license with 1 user. Please contact Controllab for price reductions on multiple licenses.

Classroom Kit

A Classroom Kit allows the owner to make unlimited copies of the software for educational purposes. Copies may be used by students and teachers.

Use

Personal Use

Personal use is for use at home and personal education. Not for commercial, government, academic or other organizational use.

Academic Use

Corporate Use

Corporate use has no restrictions.

Maintenance
